The top 6 boaters and top 6 co-anglers having fulfilled all rules will be members of the NCBF State Team. Anglers must fish 3 of 4 tournaments. Boaters will compete against boaters and Co-Anglers against Co-Anglers and payouts will reflect the winners in each division. 200 points will be awarded for the top finishing boater and co-anglers with scores for each boater and co-angler descending. A minimum of 50 points will be given to each member participating in the qualifying tournament. Payout will be for the top 3 places. Lunker is optional (\$10) with 100% payback. INCLUDE Lunker payment with application. All boats must be insured with at least \$300,000 liability coverage and submitted with each application.
